Parents' Communication Models On Children Addicted

To Pornography In East Jakarta

ABSTRACT

Nowadays, cases of addiction to pornography in children have entered a high percentage.

According to the Indonesian Child Protection Commission, 65.34% of children in age range 9

to 19 years in Indonesia have accessed pornography via gadgets. The increasing number of

pornographic content that is easily accessible to children has made cases of violence and sexual

abuse against children increasing. The National Commission on Women stated that there were

as many as 40,000 cases of violence against women in 2019. This percentage made Indonesia

change its status to sexual violence emergency. One of the strong factors is the pornographic

content that is watched from children age.

In this study, researchers used a qualitative approach. Data collection was carried out by in-

depth interviews and participant observation. The informants in this study amounted to three

people. The data analysis in this study used an interaction model by Miles and Huberman, in

which the stages are done through obtaining the data then they get reduced, displayed, and

verified. On the other hand, checking the validity of the data was done by triangulating the

sources and methods.

The results of this study are the models used in this study: permissive communication patterns

and militaristic communication patterns. Apart from communicating with children, religious

approaches are also taken by parents so that children do not fall further into accessing the

internet.

Introduction

Pornographic content in Indonesian is increasingly distributed. Advances in technology allow

people to easily access pornographic content. There are millions of content containing

pornographic elements that often appear indirectly in every activity of our virtual world.

According to the Law of Republic of Indonesia No.44 Article 1 Paragraph 1 Year of 2008,

pornography is a term for pictures, sketches, illustrations, photos, writings, sounds, moving

pictures, animation, cartoons, conversations, gestures, or other forms of messages through

various form of communication media and / or public performances, in which they contain

sexual exploitation that violates the norms of decency in society. Pornographic content is a type

of content that has a negative impact on the behavior of the younger generation. Pornography

can damage the brain on the PFC part. Children will find it difficult to concentrate, to plan the

future and even to think critically.

Although the government has blocked the access to pornography, in fact, a lot of pornographic

content are still spread. Therefore, it means that the ease of accessing pornography can also be

easily accessed by children. With internet, pornography appears anywhere, such as in movies,

TV, magazines, video clips, and even games that the children are familiar with. Currently, cases of addiction to pornography in children have entered a concerning stage. According to the Indonesian Child Protection Commission, 65.34% of children in age range 9 to 19 in Indonesia have accessed pornography via gadgets.

The total numbers of people accessing pornographic content are increasing every day. With internet, pornographic content can be accessed directly or indirectly. Hundreds of pornographic images can be seen with just a click away. The internet also makes pornography addicts feel comfortable when watching the shows because they can access in secret and their identities are hidden. Furthermore, pornographic content is currently aggressive in seeking its users to reap large profits, and there are many ways that content providers do for those addicts to continue accessing their content.

Children have a high curiosity. Children will feel happy when they find something new. When children play gadgets, sometimes obscene advertisements or impressions appear. In addition, there are still many children accessing age-inappropriate applications such as Facebook, Twitter and Instagram, in which it imposes a regulation that the users can only be over 13 years old.

The process of addiction to pornographic content initially occurs when children accidentally access pornographic content, in which it will cause a sense of discomfort and a little curiosity. However, the brain directly stimulates dopamine to be released, causing addiction to pornographic content. The more children are exploring pornographic content, the more their curiosity increases, so that they continue to access them and cause negative behavior according to what they have seen.

Parents play an important role in supervising children when playing gadgets. If children are not under parental supervision, children will continue to explore pornographic content aggressively. However, these days, many parents feel that sex education is still considered taboo

or even unimportant, whereas sex education can be the right method to prevent early childhood addiction to pornographic content.

In this study, researchers used descriptive qualitative research methods with in-depth interviews. The qualitative research method is used, so researchers can further explore the causes of problems that exist between parents and children who are addicted to pornography. Through interviews, researchers are able to explore informants, so they can get descriptive information from the informants. Since the theme of the study is considered sensitive, it made the process quite difficult for informants to express their opinions; as a result, in-depth interviews were appropriate to be used in this study.

## Material and Methods

#### **Communication Models**

## **Parents and Children Patterns**

Communication patterns are usually referred to as models, a system consisting of various components that are related to one another to achieve the goal of social education. Communication patterns are systems of delivering messages through certain symbols, containing meaning, and transferring stimulants to change the behavior of other individuals. Communication patterns can be understood as patterns of relationships between two or more people in sending and receiving messages in an appropriate way, so that the message being questioned can be understood.

#### a) Permissive Pattern

Permissive pattern (tend to be liberating) is a pattern that tries to accept and has a positive attitude towards emotional impulses, desires, and children's behavior. Parents with permissive communication pattern do not really do punishment and give their children not too much household responsibilities. Permissive parents rely heavily on communication in educating children, by explaining the consequences of all children's behavior. They let their children do whatever they want.

#### a) Militaristic Pattern

Militaristic pattern is a type of parental leadership who always rules their children. Without dialogue, children must obey their orders, must not deny the rules, must obey orders and prohibitions. In certain circumstances, there is a threat; in a dangerous situation, this type is appropriate to be used to make children become brave. Parents must be fast and accurate in making decisions for their children's safety. In certain cases, militaristic pattern with parental policies and extreme caution can be used effectively in PAUD, kindergarten and elementary school children.

# b) Equality Pattern

In this pattern, every family member has the same opportunity to express their opinion. Opportunities are shared equally and each individual is considered equal. In other words, the position of each individual is the same. Communication runs honestly, openly, freely and directly without seeing the power in it. Every member of the family has the same right to make decisions, both in simple and complex matters.

Problems that occur are seen as a threat. The problem will be observed and analyzed first. Different opinion is only seen as a natural clash that will occur if you exchange opinions regarding ideas or views towards a thing.

# c) Balance Split Pattern

In balance split pattern, equality of relationship remains, but each person has control and power over the abilities in their respective fields. In this pattern, everyone has the same knowledge towards religion, health, art and each of them is not considered better than the other. Conflict is not considered a threat because every family member has power in that area. So, before the conflict occurred, it can be easily concluded who lost and who won between parents and children.

#### d) Unbalance Split Pattern

One family member dominates and controls since that member is considered the most skilled at it. She or he is the most dominating person who is often in control. Usually, this person is smarter with more knowledge and income than others. The non-dominating sides usually allow the dominating one to win the debate. The dominating person provides firm statements and opinions, as well as regulates what the others should do. She or he will exalt his ego and rarely ask for opinions or affirm the others' arguments. On the other hand, the non-dominating ones will ask for opinions and follow the words of the dominant in making decisions.

# e) Monopoly Pattern

In this pattern, parents are considered as the rulers. Parents who command and rarely communicate, are more likely to give advice than to listen to feedback from others. Parents decide the final decision without listening to other people's opinions. Arguments rarely occur because children always follow parents' arguments. When conflicts occur, children will most likely feel hurt since they do not know how to express their opinions and find it difficult to convey disagreements. Parents will get satisfaction because of their role in educating their

children. On the other hand, if children do not obey the rules, they will be afraid if their needs are not fulfilled by their parents.

## f) Authoritarian Pattern

Parents who have this type of communication pattern try to shape, control, and evaluate children's behavior and attitudes based on a set of absolute standards, values of obedience, respect for authority, work, traditions, not giving and receiving in verbal communication. Sometimes parents often punish them.

Authoritarian communication pattern is a type of communication pattern that imposes will. In an effort to influence children, parents often use approaches that contain elements of coercion or threats, and words spoken by parents are valid and cannot be changed. Interpersonal relationships between parents and children tend to be tenuous and potentially antagonistic (in opposites). In some cases, this pattern is suitable for educating early childhood.

#### g) Authoritive Pattern (Democratic)

Democratic pattern is the best pattern type of all communication patterns that exist. This democratic type always puts the common interests above the individual interests of the child. This type is a type of parenting style that does not use much control over the child. This pattern can be used for children of any age range.

This type pattern expects children to share responsibilities and to be able to develop their leadership potential as well as have a concern for interpersonal relationships in the family. Although it will seem less well-organized, this style can run in a relaxed atmosphere and has a tendency to produce effective productivity and creativity since this pattern is able to maximize the abilities of children.

#### h) Charismatic Pattern

Charismatic type of communication pattern is a communication pattern of parents who have a strong sense of authority. That authority exists not because of power or fear, but because of the existing psychological relationship between parents and children. The existence of extraordinary internal powers that are endowed with supernatural powers from God for the parents so that in a short time they can command the child without any resistance. This type of communication pattern is good, as long as the parents stick to moral values, high honor and applicable laws. This communication pattern can be used for elementary, junior high, senior high, and university-level education children.

## i) Affiliate Pattern

Affiliate type of communication pattern is a type of parent leadership that promotes cooperation with children by joining forces. This type of communication seeks to build strong bonds between parent and child, seeks to create feelings of love, build trust and loyalty between parent and child. The intimacy between parents and children is very harmonious.

## j) Fathernalistic Pattern

Fathernalistic (fatherna or fatherly) is a pattern of fatherly communication, where parents act as fathers to children in the form of educating, caring for, teaching, guiding, and advising. Parents use the influence of their fatherly nature to command their children to achieve the desired goals, although sometimes the approach is sentimental. Behind the goodness, the weakness of this type of communication pattern is that it does not provide opportunities for children to grow up to be mature and responsible. That is why this type of communication pattern is characterized by the characteristics of parents as the leaders. Among these general characteristics, the type of fatherly communication pattern is that parents perceive children as

immature human beings, overprotective of their children, do not give children opportunities to make decisions and to develop initiative and creation, parents often consider themselves all-knowing

## k) Laissez-Faire Pattern

This type of communication pattern is not based on rules. Freedom is open to children with a little parental intervention so that the freedom given is controlled. if there is no control, unorganized, unproductive, and apathetic, its because children feel they do not have goals and objectives to be achieved. Parents who use this style want their children to participate without imposing or demanding the authority they have. Communication from parents tends to act as a liaison that connects contributions or brainstorming from family members. This communication pattern can be used for children of all ages.

## 1) Manipulative Pattern

This type of communication pattern is all about tricking, seducing, turning reality around. So that what is desired is achieved, parents deceive and seduce children to do what they want. Parents always twist the facts or manipulate the real situation. Manipulation-style parental communication patterns usually succeed in achieving goals because the child who is being treated does not know his parents' intentions.

# m) Transactional Pattern

This type of parental communication pattern always makes an agreement (transaction), where the parent and child make an agreement for every action that is taken. Parents want their children to comply in the form of carrying out the agreed agreements. There are certain sanctions imposed on children if at any time the child violates the agreement. This communication pattern is suitable for elementary and junior high school children.

#### n) Consultant Pattern

This type of communication pattern makes itself as a place for children's complaints, opening up to be good listeners for the children. Parents are ready with children to listen to stories, information, news, and complaints about various things that children have brought from their life experiences. Two-way open communication between parents and children where both have different positions and roles, parents act as consultants and children act as people who convey messages. Both are involved in dialogic communication about everything. This communication pattern can be used for children of all ages.

## o) Role Transfer Pattern

Is a type of parental leadership by delegating authority and responsibility to children. This communication pattern is used by parents who provide opportunities for children to carry out certain tasks and roles. Parents only facilitate and help provide solutions when children getting into troble. Although not directed in detail, the responsibility and decision-making process is left to the children. The delegation of authority and responsibility to children will work well if the children understand and are efficient at work.

# Pornography

According to the constitution no. No.44 of 2008 article 1 paragraph 1, it is stated that pornography is pictures, sketches, illustrations, photos, writings, sounds, sounds, moving images, animation, cartoons, conversations, gestures to other forms of messages through various forms of media communication and / or public performances containing obscenity or sexual exploitation that violates the norms of decency in society.

The Britainia Encyclopedia (www.pemantauperadilan.com, MAPPI-FHUI) states that pornography is the representation or erotic behavior, as in book, picture or films, intended to

cause sexual excitement. According to this definition, what is meant by pornography is erotic behavior that is displayed in books, pictures or films that are shown within sexual activity. In its original meaning, pornography literally means "writings about prostitutes", originally a euphemism and literally means "(something that is) sold." This word comes from the Greek term for people who recorded "pornoai," or famous or highly skilled prostitutes from ancient Greece. In modern times the term has been taken by social scientists to describe the work of men such as Nicholas Restif and William Acton, who in the 18th and 19th centuries published treatises studying prostitution and proposed suggestions for regulating it. In modern times the term has been taken by social scientists to describe the work of men such as Nicholas Restif and William Acton, who in the 18th and 19th centuries published treatises studying about prostitution and proposed suggestions to regulate it. This term remained in use with this meaning in the Oxford English Dictionary until 1905. Later, the term was used for the publication of anything with a sexual nature, in particular those deemed in poor taste or immoral, when the manufacture, presentation or consumption of the material was only intended to give sexual arousal. Today the term is used to refer to sexually any kind of written or graphic material. The term "pornography" often has negative connotations and has less artistic value than erotica, which is more respectful. Euphemistic terms such as adult films and adult videos are generally preferred by those who produce these materials.

However, the definition of pornography is very subjective. Works that are generally recognized as art, such as Michelangelo's "David" statue are considered pornographic by some. Sometimes people also distinguish between light pornography and heavy pornography. Light pornography generally refers to material that presents nudity, scenes that are suggestive of a sexual nature, or mimic sex scenes, while heavy pornography contains images of genitalia in a state of arousal and sexual activity including penetration. Within the industry itself a further informal classification is carried out. These distinctions may seem insignificant to many people, but the

uncertain legal definitions and varying standards at different suppliers also cause producers to shoot and edit them in different ways. They also first consulted their different versions of their films with their legal team.

Referring to the opinion of Armando (2004), there are several stages of the effects of pornography, such as:

#### A. Addiction stage (addiction);

In the era of increasingly developing technology, people already have sophisticated communication tools and other electronic devices such as Hand Phone (HP) / tablet, laptop, computer, etc. This tool is one of the media that can be used by anyone to access and view pornographic content. With the accessibility for both the tools and the ways to operate it, everyone, including children, can access pornographic content.

Referring to the opinion of Kastleman, (2007), which states that the use of pornography via the internet is easy to access, without paying (affordable), the display attracts attention to be seen, raises further curiosity, is easily disseminated (aggressive). Porn site users will not be recognized / known to other people (anonymous). This means that pornographic content is very easy to access because in this day and age, all people, even children, are equipped with Hand Phone (HP) or tablet from their parents that is sophisticated, has an internet package that can be arranged by the owner, with the aim of facilitating communication between parents and children. However, the Handphone is also one of the easier means of accessing whatever the owner wants via the internet. Apart from Handphone / tablets, television is one of the electronic means owned by every household that can also be a source or tool for viewing pornographic content.

# B. Escalation Stage (escalation);

The escalation stage will occur when children are addicted to pornographic content. Even though at first most people were invited to view pornographic content by their friends, but when children have experienced an escalation where pornographic content is something they usually see, then there is no need for someone or friends to invite them. With the accessibility and facilities that are owned, children can directly access pornographic content, and find what they want themselves.

# C. Desensitization Stage (Desensitization);

Pornography addicts who are already at the desensitization level consider pornography to be commonplace, so there is a tendency to create and share the content with others.

# D. Act-out stage;

The act-out stage is one that gives bad consequences not only to himself but to others. At this stage the porn addict will practice what he sees in the pornographic content.

# **Results And Discussion**

The study entitled The communication patterns of parents with children who are addicted to pornography in the East Jakarta area, took three informants. The three informants are from the East Jakarta area, but they live in different locations. The three informants were able to provide sufficient information in this study. However, all informants requested that their identity be kept secret because it is not easy for a parent to provide information about their children's behavior. Moreover, the problems that the children experienced are quite severe where the child likes to see pictures, videos, or anything else related to pornography. They can access all of them via gadgets or computers that are connected to the internet. The following are the

results of the researchers' interviews with the three informants regarding the communication patterns they apply to their children.

## 1. Parents' Communication patterns of Pornography Addicted Children

Communication is an activity that we do every day as social creatures. Nowadays almost all work involves communication activities. Not only work, in our daily life from waking up to before going to bed we cannot be separated from communication. Communication here is not only with others like friends, relatives, children, wives, husbands, or other families. Often times we communicate with ourselves.

Communication is important so that everything that is done can be coordinated properly and avoid conflicts due to lack of communication. Especially communication between parents and children. Communication between the two is important, especially when children are under 10 years of age. Children of this age still need direction and guidance and cannot be taken off from our eyes. In today's era, we cannot leave children without parental supervision.

Technology that is increasingly developing does have a positive and negative impact on children. Nowadays children are inseparable from technology. Along with the development of the times, children's activities in the current era are very different from the previous era wherein that era, children spent more time with their peers, and also played games that are appropriate for their age. It is different from the current condition where children live with increasingly advanced and developing technology. Children in the current era are presented with sophisticated technologies that make them accustomed to exploring the world widely. The development of children's games, as well as various sites on the internet, has become a charm on its own for children. Websites that are currently developing on the internet can be accessed easily by children. In this case, parents have the key role to make their children have the ability to filter out information they have access to.

The informants in this study are parents who have children who like to access sites on the internet, especially those related to pornography. Their children's indulgence started only because of their curiosity which ended with them liking it. Parents busyness make these children freely open pornographic sites.

The government in this case, has closed content related to pornography. Even though the children now cannot fully see that content anymore because of the closure of pornographic content, children can still see the pictures passing by on the internet, even if only for a second. Not only that, through games, children can also view pornographic content.

As happened to the interviewee's, AS, son. Parents' with tons of activities and having a household problem might create a situation where their son is given an uncontrolled access of internet since their son is equipped with high-tech gadgets. That uncontrolled access lead to a condition where her son ended up in addiction to using gadgets. Not only being addicted to using gadgets, but he is now really into pornographic contents. The behavior of AS's son is actually triggered by the condition when AS experienced the disharmony of her relationship with her husband. AS's husband, ASE, has a sexual orientation disorder. ASE was once no different than any normal men out there who like women. The shifting of his orientation occurred when this couple undergone a long-distance relationship, the exact condition that caused him changes his orientation to be same-sex orientation. ASE is actually has this kind of feeling for a very long time, but he continually managed to turned it down. ASE, who is the father of KL, often expresses his sexual abnormalities when both are taking a bath together. It seems normal at the first place, where father is taking a bath with his little kid, but from AS's point of view, as KL's mother, this condition plays part in influencing KL, her son, to has an inclination towards pornographic contents. KL's addiction of pornography is spotted through his browser history, where KL oftentimes searched about this pornographic contents in his

gadgets. Besides, when his mother asks about this issue, unexpectedly, KL tells about it truthfully, even he is willing to explain his imagination in details to his mother. Here is the transcripts of the interview with AS, KL's mother, regarding the issue experienced by her son.

"KL has a severe addiction to see those kind of things. Sometimes, when I ask for his phone so then he will not be able watch such things, he is instantly going berserk. Nevertheless, this condition scares me too since I am afraid that it will gives negative impacts to him, so at the end, I turn his phone back. There was one moment, when I scolded him, he just did it again. It is like, he never listened. That's why, his housemaid once invited him to Garut, to the *Pesantren* with a thought in mind that he will finally changes his behavior but, sadly, it ended the same way. The most shocking part is his imagination. He once told me, "Bunda, I want to be a Sultan who has a lot of money so I can spend it the way I want, and I am surrounded by lots of women. I oftentimes get shocked when I hear him saying such things. Furthermore, he is also now able to edit some kind of pornographic pictures, even though no one has taught him. What else I could do? I work every day and obviously when I go to work, KL is at house with his housemaid. His father doesn't care at all, even just giving money to us once in a month. He doesn't." (An interview with AS on August 19, 2020).

Through the aforementioned interview with AS family and ASE, religious approach is being used to get KL rid of his addiction, but, sadly, this action is not effective enough to solve this issue. His father's sexual orientation disorder indirectly influences KL to skew pornographic contents. Parents' role really matters in here since in KL's case, inattentiveness from both of his parents, making him spend most of his time to access internet through his gadgets. The difficulty of relinquishing KL from gadgets which filled with pornographic contents, makes AS, his mother, to feel despair, and just let it be up until now.

A lot of communication methods have been used by AS to make KL, her son, stop using gadgets and accessing negative content. However, this all means nothing. His mother, AS, has come to a state of being where she just wants to give up. Moreover, her mother still thinks about her own life and spend some time occasionally to see and remind her kid. Lack of attention will makes KL more skew to negative contents on the internet.

The "angel" communication model is finally chosen by AS, KL's mother, to make her kid gradually leave the gadgets and all the pornographic contents within. This "angel" communication method is chosen due to the situation where the more KL receives harsh treatment, the more rebellious and uncontrollable he would become.

Different from the communication model used by AS to her kid, KL, for this interviewee, DV, is using a communication model to her kid, SA that is quite opposite. DV is inclined to use the "devil" communication model in the sense that violence and assertiveness are being employed. When it looks to the family condition, DV's family is unlike the US's family since DV's family is more educated. The mother, DV, has a disciplined, tough, and firm attitude. The harshness expressed by the mother actually makes her kid more curious. The lack of understanding and comprehension made her son, SA, often find out about pornographic things all by himself. DV's husband, who also the father of SA, DW, is not too strict in educating their son. So between, DV and DW are contradictory in educating their son. The father tends to gives freedom to his son. This also often causes a fight between DV and DW. Even though both often got into fights, DV still insist to educate their kid the way she wants despite of making her fight against her husband, DW.

In this case, DV strictly does not give permission of having a gadget to her son. Gadgets can only be accessed on weekends, and is limited to features and applications selected by DV, the mother. The assertive behavior that DV did to her son, SA, made her son have even a higher

curiosity. In this case, DV knows that her son likes to access pornographic contents from the child's conversation. SA often asks DV about pornographic matters. It was through the conversation that made DV suspicious of her son. SA is the type of child who does not rebel because he understands that the more he rebels against his mother, the angrier he will get from the mother. The silent attitude of this child needs to be watched out more than the very active child. Because the silence that was experienced by SA made it even worse. The more SA was restrained by her mother, the more she didn't deter her. However, in this case, the mother remains consistent in her attitude towards her son.

For the first interviewee, she is kind of afraid of the outcomes which might make her son worsen than before therefore she tries to succumb. In contrast with DV who does not let her son despite being rebellious or become stubborn. DV uses punishment to SA if he breaks the rules or tries to rebel against his mom. Following are the answer of the interview with DV.

"For me, I try to act consistently towards my son for once we lessen our guard, our son would easily spot it. He might think, "Mommy is actually easy to be tricked with that way." Truthfully, I can't use those subtle methods in dealing with this matter. If he refuses to obey what I'm saying, I order him to get out of the house, and automatically he becomes afraid. They know if I'm mad. I always check what they usually access and see on their gadgets, and if get caught, they know they would get punishment. But after all, I found out that my son is the type of kid who if they are treated harshly, they will become curious. I knew it when he asks about pornographic matters. (Interview with DV on July 30, 2020).

Through the results of an interview with DV in regards to the act of advising the child assertively actually makes the child even more curious. However, DV as a parent will be consistent with her attitude and her way of educating and correcting her son. DV does not care

even though she will be said to be fierce like the devil and she will keep like that up until then. She will also remain firm towards her son.

DV thinks that her son cannot be given a gap or indulgence from his mother. DV has made this a habit for her son to be independent. DV strongly adopts western culture in educating her son. The western style in educating her son seems already fit to be applied in her life. DV does not want to spoil her son.

To prevent her son from getting severe addiction in accessing pornographic content, DV tries to give him a lot of activities such as calling a reciting tutor to her home. This way is done to avoid SA in searching for other pornographic contents through her gadgets. She is fully aware that this is not easy to make her son want to recite the Quran, but with a loud and angry tone, DV always forces her son to follow her command.

Distinct from the third interviewee, this last interviewee tends to be similar to the first interviewee since she does not restrict her son from using gadgets. She lets her son using gadgets every day either for accessing the internet or playing mobile games. By giving freedom to her son from using gadgets, she assumes that it will make her son stay at home and will not leave the house. RD, as the mother, does not like to see her son go out and hang out with her friends in their complex. Even, she lets her son using gadgets every day with unlimited access to the internet, and neither he is being monitored nor his search history is being checked.

The less guard shown by RD makes her do not know her son's situation which he is oftentimes accessed and see pornographic content on the internet. The negligence RD as a parent to guard and company her son while surfing on the internet makes AK, her son, feel free to do whatever he wants on the internet.

RD is busy selling cakes every day. RD usually leaves the house since 3 a.m in the morning to shop the cakes for resale. So that her time is spent to work. Even though she spent her whole day to work, when she came back home, RD did not immediately meet his children. RD often relaxes herself and leaves the care of his household assistants. Following are the answer of the interview with RD.

"I prefer to not let my son go play outside, therefore, to make him comfortable at home, I give him gadgets for entertainment purposes. When I already gave the gadgets to them, they are all settled. What makes me forbid them from getting outside playing with their friends is I'm afraid that they will get into fights with their friends. So that is, I decided to not let them play outside. Let them use gadgets for whatever they want as long as they are staying at home. AK is usually playing some games and I know some games consist of women with sexy costumes or illustrations. I often see those games but, as long as they do not mess around, so I let them. Not only playing games, but also they are surfing on the internet like almost every day. That is why they never get bored to stay at home. They even can spend hours at their room just to play video games, and only stop when I yell at them to eat lunch or dinner. After all, I never check what they usually see on their gadgets, I only receive some report from his housemaid when AK sees something unusual. (Interview with RD on July 21, 2020).

Through the above interview, this third interviewee does not have any firmness or concern for her child in accessing pornographic sites or features. RD tends to free his children without monitoring her son's activities in using gadgets. The activities carried out by AK were informed by RD's household assistant, event about those pornographic content. Even though she knows her son's activities in using gadgets, including his activities in accessing pornographic content, RD does not stop him anyway from using gadgets to access those features within. Despite having a settle household and is different from AS and ASE family, which resulted their son

got neglected since both are busy with their own business. However, the role of parents is very lacking for their son. RD live separately with her husband. Her husband mostly spend his time at the apartments and only pay a visit to RD's house occasionally. RD's husband is no different with RD, both are tends to not care of their son's development. RD prefer to leaves all AK's matters to the housemaid who is being called as Bude. All of Ak's behavior are being reported by the household to his mother, RD. In this case, RD also tries to prevent AK from being constantly tempted to view pornographic images which he can easily access from his gadget. RD's efforts does not differ much from the first and second interviewee. RD invites AK to attend the recitation which is held in his complex.

Based on the research above, there are three aspects of the findings obtained from the results of research with speakers. First, the religious approach is an effort made by parents in this regard. Religion is considered capable of changing the behavior of children who like to see negative features on the internet. Apart from the second aspect of the religious approach, namely, the role of parents is very important because many children are not cared for in this case because their parents are busy working. Feeling tired after work makes parents sometimes forget to company their children.

Moreover, those children are still very young, and these days, they are all managed to access the internet on their own since the era has transformed into a self-taught era. No need to bother teaching these kids to make them be able to operate the internet since by watching their parents use the internet and gadget alone, they will soon know how to operate it.

Third, the heredity from parents who experience sexual orientation disorders can trigger children to indulge in pornographic content. Children under age are still vulnerable to absorbing and receiving information. Not only that, but parents also become a reflection of children. What is seen and felt will be emulated. For this reason, assistance becomes an

essential factor so that children are not too free to explore the virtual world. Some restrictions need to be applied, such as locking websites that are prohibited for underage children, and the parents need to regularly check or browse what their children have access to. To minimize their behavior from becoming even wilder. It is undeniable that cyberspace is something that can have a positive impact but can also have a negative impact, especially for children. Children will not fall further if parents pay more attention even though they have to divide their time to work. Children are affected by pornographic content because of the freedom their parents give to them. Apart from that, the busy factor of parents is also the cause. These children become off guard of their parents' observations. Although there are restrictions on accessing the internet, children of this age have a deep curiosity. So that they will continue to search for and try to access these contents secretly so they will not get caught by their parents. The key to overcome this issue is the parents must be able to filter what is given to their children so that they do not become a boomerang for parents

#### Conclusion

Based on the findings of the research and the discussion, the conclusions of this study are as follow:

The permissive Communication Method (tends to liberate) is a method that seeks to behave accepting and being positive towards emotional impulses, desires, and children's behavior. Parents with permissive communication method do not really into the application of punishment and give their children little chores responsibilities. Permissive parents rely heavily on communication in educating their children, by explaining the consequences of all their children's behavior. They let their children do whatever they want. This method fits to describe the communication carried out by the first and third interviewees. Given that these two interviewees tend to give more freedom to their children in using gadgets, not to mention the freedom without control what their children are doing and what their children are seeing on the internet. The more liberated the children, the harder it gets to get them away from pornographic content.

Another method shown by one of the interviewees is militaristic communication method. This method is a type of parental leadership who always set up rules without any dialogue, their children must obey their orders and prohibitions. In some cases, if there is a threat, and in critical situation, this method perfectly matches to be employed in ordering their children. Because they have to be fast and precise in making decisions for the safety of children. In certain cases, militaristic communication method with a thoughtful parental policies can be used for early childhood, kindergarten and elementary school children. This method really well in portraying the situation of the second interviewee where in daily basis interaction and communication are more assertive or can be said tend to be militastic. All the rules that are

applied must be obeyed by their children. If the children violate the rules that are already agreed upon, they will be punished. However, this method will not be effective enough if it is being used for a long time. Proven by the situation undergone by this second interviewee, when the situation seems under control, but behind his parents, these children secretly try to find out about it.

Based on the discussion above, it can be concluded that the two communication methods are not biased to be applied to their children who like to access pornographic content on the internet. There must be some sort of formula that can overcome this issue so then these children can stop their addiction and live a normal life like other children of the same age. Moreover, even though the religious approach is taken as the method, this will require a long process to change this all. For that, the right solution to overcome this issue lies in the role of the parents in the household. Control, assistance, and being selective about what their children can do become important matters to do. For once these parents can filter what their children can access and see on the internet, their children will not fall to the same hole anymore in the future. Besides, changing the communication method is considered to be important if only the children are kind of rebel and difficult to control. Those parents, in this case, must have a better understanding of the situation and condition of their children.
